TriNet is a privately-held company that secured an equity investment in 2005 from **General Atlantic, LLC**, a leading global private equity firm with more than \$18 billion under capital management. GA now serves as TriNet's majority stakeholder and focuses its investments on companies providing or using technology to drive business growth. Established in 1980, GA has more than 200 employees based in Amsterdam, Beijing, Dusseldorf, Greenwich, Hong Kong, London, Mumbai, New York, Palo Alto, Sao Paulo and Singapore.

TriNet is also audited on a quarterly basis by an independent auditor as part of the requirements to maintain our accreditation with **Employer Services Assurance Corporation**. ESAC is a non-profit

organization providing independent application and monitoring of important areas such as ethical, financial and operational requirements and responsibility standards for companies performing outsourced employer services. TriNet is one of only six PEO firms to have received continuous accreditation since ESAC's founding in 1995.
